4. If there are more than 3 events, set the severity of the event to Major
5. If there are more than 5 events, set the severity of the event to Critical
6. Return the event to the ObjectServer with the updated columns.

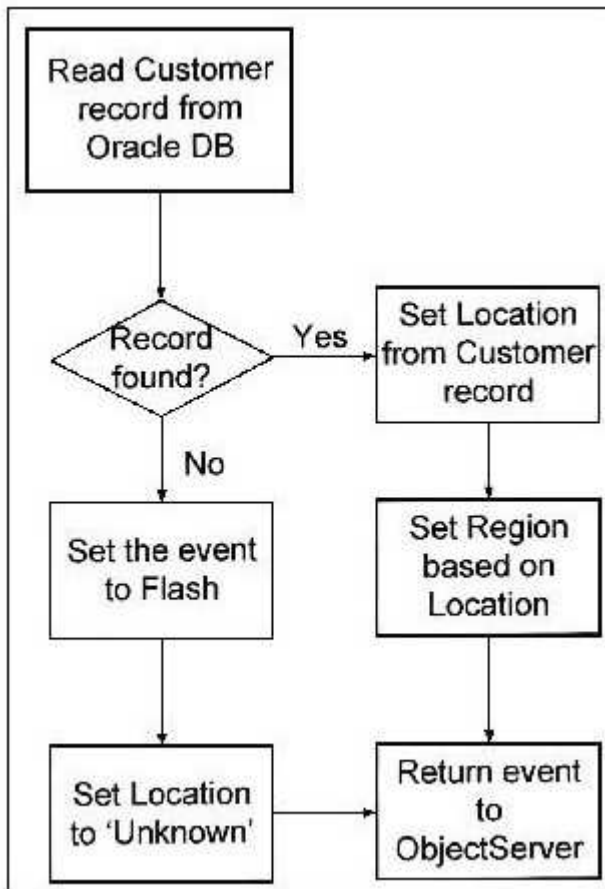
